Texas Title Insurance Guaranty Association Guaranty Fee First Quarter 2013 Report

The Association received and deposited \$548,170 allocated to the first quarter of 2013. This sum represents approximately 274,085 policies. See the history of the collections in the Table entitled, "Guaranty Fee Policies by Quarters" on the next page.

On March 31, 2013, there were 572 licensed agents, an increase of zero (0) from the previous quarter. During the first quarter, six (6) agents' licenses were cancelled, revoked, or suspended. We received remittances from 571 agents—32 remittances were late. There were six (6) agents who did not remit: three (3) were new and may not have fees to remit; two (2) were suspended and may need to remit "final"; and one (1) did not remit for unknown reason.

As always, a late notice is sent to all late remitting agents reminding them of the due date. A notice is sent to all agents who fail to remit. All information concerning both groups of agents is forwarded to the Texas Department of Insurance ("TDI") for further action.
